### **Background**

#### **Community vision & context**

- Little Howrah Beach is a muchloved coastal place for residents and Greater Hobart users (families, kayakers, swimmers).
- The draft Master Plan builds on what works to create a more accessible, attractive and connected destination while respecting heritage character and setting.
- Aim: coordinated upgrades that support recreation and transport connections and make the area resilient to climate and coastal change.

#### **Objectives & design responses**

- Objectives: make the beach inclusive and accessible; create high-quality public spaces and amenities; support existing and future users; protect and enhance coastal biodiversity; adapt to climate, sand movement and waterway health.
- Key design moves: new beach plaza with seating, shelters and fully accessible ramps; widened footpaths, new cycling lanes and upgraded bus stops to strengthen active and public transport links and enable a future ferry; relocated and upgraded public amenities; coastal plantings, lighting and signage to lift safety, amenity and biodiversity.

#### **Consultation overview**

- Purpose: present the draft Master Plan and check that Phase 1 (2023) feedback is reflected; test support for key elements and identify any concerns or priorities to inform the final plan and implementation.
- Timing & methods: 2 Dec 2024 to 8
  Mar 2025 during peak summer use;
  online and hard-copy survey, written
  submissions, and a public display at
  Howrah Point Shopping Centre.
- Feedback sought: targeted questions on major features (e.g. Beach Plaza) and items likely to attract mixed views, plus overall sentiment and priorities for delivery.

Feedback is generally supportive, noting that the purpose is to test ideas and determine whether changes are required.

## **Key Findings Summary**

#### **Overall sentiment**

The draft Little Howrah Beach Master Plan was generally well received by the community. Across survey responses, display comments and written submissions, the clear message was that people love Little Howrah Beach and welcome investment to make it safer, more accessible and more enjoyable.

The Beach Plaza, landscaping, accessibility upgrades and better amenities were consistently highlighted as valuable improvements. Most people expressed support for the vision, subject to detailed design and practical considerations.

### Written submissions vs community survey responses

The 11 written submissions provided valuable insights, particularly from residents living immediately adjacent to the site.

Written submissions tended to be more skeptical than the general survey responses and display feedback, especially on issues such as toilets relocation, ferry feasibility, and the impact of changes to parking.

In contrast, survey responses and display comments from the broader community leaned more supportive overall, while still flagging concerns about capacity and detail.

This distinction highlights the importance of considering both localised impacts and broader community benefits.

#### **Balance of views**

Although critical comments were often detailed and passionate, the balance of feedback across the survey, submissions and display comments remained supportive overall.

For most people, the draft Master Plan represented a positive step forward for Little Howrah Beach, with the qualification that implementation needs to be careful, responsive and staged.

#### **Most valued improvements**

Across all consultation channels, there was clear support for improved accessibility and inclusivity, and particularly the beach access ramp and safer walking and cycling links.

People also valued upgrades to toilets and amenities, landscaping and shade trees, and the creation of better gathering spaces such as the Beach Plaza. These were seen as long-overdue improvements that would modernise facilities and enhance the everyday use of the foreshore.

## **Key Findings Summary**

#### **Recurring concerns**

The consultation also highlighted a number of consistent concerns. The most frequently raised issues were:

- Relocation of the public toilets from their current site to the Beach Plaza
- Parking capacity and management, particularly loss of on-street spaces along Howrah Road and the risk of overflow into residential streets if a ferry service proceeds
- The scale of proposed works and the risk of 'too much concrete' or overdevelopment of a place valued for its natural feel
- Environmental and coastal impacts, including erosion, sand movement and biodiversity
- The cost, staging and long-term deliverability of the plan.

### Key Findings at a Glance Q



Strong support for making Little Howrah Beach more accessible and inclusive.



Beach Plaza identified as the top priority for implementation



Parking changes and toilet location were the most debated issues



Concerns about **scale**, **materials and environmental impacts** were noted



Written submissions from **local residents** raised stronger opposition to parking changes than survey respondents overall



Majority of feedback shows **enthusiasm for the plan**, provided design is **careful and staged**.

### Conclusion

Community consultation for the draft Little Howrah Beach Master Plan showed the community strongly values Little Howrah Beach and is enthusiastic about City of Clarence's commitment to improving it. Overall, the Master Plan was well supported, with most people welcoming upgrades to accessibility, landscaping, amenities and community spaces.

While the feedback identified recurring concerns, particularly around potential relocation of the public toilets, traffic and parking impacts, ferry feasibility, scale of works and environmental impacts, these issues can be addressed through detailed design, careful staging and further engagement with the community. Written submissions from nearby residents provided important local perspectives, while survey and display responses highlighted broad community enthusiasm for the plan.

The key overall finding is that the community wants Little Howrah Beach to have facilities and connections that meet modern needs (and particularly improved all abilities access to the beach) but retain its charm and local character and not become overdeveloped or too busy.

The Master Plan provides a coordinated framework to achieve this.

The Master Plan's vision for Little Howrah Beach and the designs for the various components will be refined and the issues raised through this consultation will be addressed through further consultation, planning and design for implementation of the master plan, which will take place in stages, as funding and other community priorities allow.
